- General notes:

- This award chart is valid for award travel for flights only, in Economy class, on flights operated by Scoot only. Flight redemptions on ScootPlus and selected routes (Jeddah) are currently not available.
 - Redemption of Scoot award flights can be done through flyscoot.com or Scoot mobile app. This service is not available via Scoot's Hotline, KrisFlyer Membership Services or Singapore Airlines Reservations and Ticketing offices.
 - KrisFlyer miles shown on this award chart is for a one-way award flight (base fare only). Taxes, surcharges and fees are applicable in addition to the redemption mileage required. Add-ons may be purchased separately for award flights.
 - Add-ons, taxes, surcharges and fees are payable in the currency prescribed with our published fares, unless stated otherwise.
 - Child discounts do not apply. A child nominee requires the same number of KrisFlyer miles for award redemption. Award flights are not applicable for infants. Contact us to request an infant to be added to your award booking.
- The 20% Scoot Discount voucher (KrisFlyer Milestone Rewards) and promo codes may not be used in an award redemption.
 - Name changes to and requests to divide award bookings are not permitted.
 - Route changes are not permitted. Date changes are permitted, subject to additional service fees and award availability. Award level difference may be payable. If the new journey requires fewer KrisFlyer miles, the excess cannot be refunded.
 - Award flights are non-cancellable and non-refundable except for the following reasons:
 - Medical reasons
 - Death of passenger or immediate family members
 - Schedule change or disruption affected with retiming of 2 hours or moreRefund will be in KrisFlyer miles and mode of payment
 - Award flights are not eligible for upgrades to ScootPlus.
- Itineraries containing connections to other airlines and codeshare flights operated by other airlines are not applicable for redemption.
 - Award flights are subject to seat availability at the time of redemption. Waitlist is not permitted.
 - Eligible routes are subject to change without prior notice.
